### 1. Call to order and call for changes to the agenda

Board of Directors were present excepting Amanda McKaig and Emily Mixon. Alternates Carrie Ezzell and Collin Roland were present, with Collin Roland acting as secretary; a quorum was established. Alderperson Grant Foster present and Supervisor Kristen Audet present. No changes to the agenda were made.

### 2. Review and approval of minutes of the June 11, 2019 meeting

Change to item 5 (p. 3): replace language with the following "Carrie receives newsletters and delivers them to block captains." No further amendments suggested. Patrick Soukup put forward a motion to approve the minutes, motion seconded, unanimously passed.

Two welcome letters are presented to the board, one version for the newsletter and one for a flyer to be delivered to new residents.

#### 5. Discuss proposition of ECA liaison to 'Hi Neighbor!' Newsletter

Bobbi Nowak proposes ECA liaison to 'Hi Neighbor!' newsletter to attend quarterly meetings. Kathy Soukup attended previous quarterly meeting. There are two new individuals working on the newsletter. Breanna Illene volunteers to attend quarterly meetings if available, other board members offered to fill in as necessary.

# 6. Updates of city committees/commissions (Grant Foster, Alderperson, and Kristen Audet, County Supervisor, if present)

Kristen Audet (Dane County Supervisor): Notifies us that zoning committee meeting conflicts with ECA meetings. Kristen has posted updates to Nextdoor and Facebook. Jail South Tower addition approved. Two additional resolutions for criminal justice improvement being reviewed by the committee. Kristen in process of being appointed to homelessness committee and has an article introducing herself planned for the next 'Hi Neighbor!'. There was a discussion of water quality issues.

Grant Foster (Madison Alderperson): Updates posted on Nextdoor and Facebook. Common Council meeting often interferes with attending ECA. Assigned to transportation, economic development, regional transportation, and sewerage district boards/committees. Grant is also closely following the review of government structure committee. There is the potential for creation of a joint county/city PFAS taskforce. Regulatory threshold of 20 ppt combined PFAS has been proposed. Buckeye Road construction is underway and Garver Feed Mill is near opening. Dogs in Parks (revising ordinances pertaining to onleash dogs in parks) survey is forthcoming (hopefully next week). There will be a listening session at Sennett middle school on July 30th. The Golf Task Force was approved and Grant has put his name in the hat for membership. City budget is running a \$9 million deficit due to revenue restrictions from the state.

There was a request from ECA board members to cc: all board members on any communications sent out by the board.
