3) ECA Events:

4) **F-35**:

Fred went on field trip to Cherokee Marsh, planes scared the kids. Heard from teachers at local schools that it can be disruptive.

Comments closed Nov. 1, final EIS forthcoming.

Mayor Rhodes-Conway quoted in news story: "If preferred locations are known to have significant negative impacts as shown in the final EIS the Air Force must be prepared to prevent and or fully mitigate those impacts. Absent that, it will not be possible for me to support the selection of Madison."

Should ECA write a letter? Who to? Alders? Alder and County Supervisor have represented us so far, so thank them and reiterate the issue to them.

Signs: at Willy St Coop, Crystal Corner party 7-11 on Wednesday will also have them.

Fred makes a motion to write a letter expressing concern and supporting the efforts of our elected officials to consider the impact of the F-35s on our community. Amanda seconds. Fred will draft letter.

- 5) City/County Updates: Grant is at the City Budget Meeting. His sponsored or co-sponsored amendments are listed in his recent update (11/12/2019).
 - BRT
 - Increase affordable housing
 - Dempsey noise control at railroad intersection
 - Vision Zero
 - Complete Streets

Breanna notes that two Alders (Michael Tierney, D16 and Donna Moreland, D7) are proposing an amendment to cut staff funding for new Pinney (\$194,000 eliminated) in order to increase funding for Fire/Rescue. This decrease would mean no new staff for the new Pinney space (it is a larger space and so this would mean not enough people to staff the space and a reduction in programming).

7) Treasurer's Report:

Ash Trees

Dan added info to October (Tree Health Mgmt for treatment of 33 Ash Trees). Highlights that we have a lot of money to raise by 2021. We got \$250 from the Beer Garden as a donation. \$5140 left to raise.

We are responsible for 33 trees. Hundreds of people donated in 2015, ECA donated the majority in 2018. We need to raise money for 2021.

Ed raises point: Have we ever voted on treating these trees in perpetuity?

Dan: We had votes in 2018 about buying T-shirts, and at decision points about paying in 2018. No contractual agreement for future. We will vote every time.

Amanda, willing to form a committee for fundraising for 2021. Parthy Schacter <u>civilhands@yahoo.com</u> has coordinated in past.
