5. Updates from elected officials

Updates from Grant Foster

Zoning changes put forward a few months ago, went through Plan Commission, recommended for approval, Common Council referred to May.

Two categories: residential and mixed use

Residential: minimal impact on Eastmorland, current parcels zoned TRC4, SRV2 would be impacted. Primary change is getting rid of dispersion requirement (right now if you want to build a duplex or 2 unit, you need special permission).

Change would be \rightarrow Permitted use process, city agencies would review, no public hearing at plan commission etc. this would be for higher units (up to 36 in CCT).

Importantly, today, any building needs to be mixed use (commercial on first floor), need conditional use for straight residential.

Grant supports density in general, need more housing etc. concerns about lacking plans for making new housing affordable. Grant very concerned about losing commercial space in the area.

Ed: voices concern about lack of public input, concerns about decreasing opportunities for individuals to purchase homes.

Brian: appreciates emphasis on expanding opportunities for housing. Anything we can do to support Grant on council?

Grant: alternate proposal, still require conditional use process for all-residential. Cottage Grove activity plan \rightarrow review and think about. Represents Eastmorland participants.

Updates from Kristen Audet

Voit Farm: I met with county Land & Water Resources staff and requested any updates on what they knew about the Voit Farm project. County staff has met with the Save the Farm Group. County staff have encouraged the group to apply for Dane County Conservation grant funds. The municipality in which the land is located needs to lead projects such as these and the county can support those efforts with things like grants.

American Rescue Plan: Dane County is set to receive approx. \$100mil in federal funds to assist with COVID response and recovery. These funds can be utilized through 2024. Initial discussions about allocations have just begun but the previous priorities of funding housing, food, human services, local businesses, public health, and workforce support remain. We might be able to utilize funds to support rural broadband development--and, we have just created a Rural Broadband Task Force.

Licensed establishments in Dane Co can receive a 30% credit which will provide financial assistance to more than 3,500 qualifying establishments in Dane County. The funds for this credit ceom from a transfer of funds from Public Health's reserve fund back to licensed establishments. Public Health is offering this credit to show support for operators impacted by the pandemic and return some of the licensing fees that operators had previously paid.
