

Upcoming events

- Tunes on the Triangle August 24
 - About \$400 was raised last year. Group consensus is to raise general funds.
- Eastmorland Park cleanup/weeding and seed collection: idea to work with Parks on the parts of the land that Parks hasn't been able to keep up with as much
 - Discussion about starting a Green Team for projects in different locations: Bike greenway, Starkweather path in OB Sherry, Ontario Park potentially as well opportunities for volunteers to manage greenspace for native plants. Educational campaigns for native plants and invasives also
 - · Joel offers to do a video about invasives
 - Invite Parks to ECA with neighbors interested to informational meeting
 - Putting out feelers on FB and Nextdoor
 - Rebecca will organize a weeding event at Eastmorland Park

Ash trees:

- Grant suggests putting \$0 toward ash trees because Parks does some work on it now and the trees are not in a crisis moment of mass die-off. If there were an important ash tree in a location we like, we could prioritize it, but Parks already treats what they consider key trees.
- Breanna mentions it is a large expense that hasn't had an end date
- Grant & Dan summarize how emerald ash bore was devasting trees across the city in the past, and treatment of trees made more sense because Parks was taking down ash trees that weren't being treated. Now Parks does not have that policy but will take them down if they get sick, though the rees are at lower risk now.
- 22 of the trees last treated by ECA funds were in Olbrich Park
- Group agrees to not actively fundraise for ash trees in the future but to honor past donations made for that specific purpose

Pride picnic:

Brian makes motion that the ECA funds the 2023 June Pride event for \$100 with a neighborhood grant

Micah seconds

Common Grace

Staci: ECA is welcome to extend the Santa visits to make it a bigger event and to hold it at Common Grace

Common Grace church recently created Eastmorland Community Center (ECC) nonprofit. Signed MOU with Threshold Sacred Development (Tyler Krupp with Mark Elsden) to work on redevelopment of the church as a community space.

ECC has a board with pastors, 3 other community members including school teacher, theatre group member, and PTO member. Interested in diversifying board and rebranding the property as Eastmorland Community Center but church will retain ownership of property

Dan: on our website there is a 50th anniversary booklet with historical information. We talk about ourselves as a neighborhood association and function that way in terms of the City, but has had the name ECA since the beginning

Staci: wanted to check in with ECA that it's not too close to the name to call it Eastmorland Community Center

ECA doesn't have a trademark

No concerns are raised

Brian motions that ECA does not object to use of the name Eastmorland Community Center

Rebecca seconds
